The 56th Schools Dance Festival which is jointly organised by the Education Bureau and our Association with venues sponsored by the Leisure and Cultural Services Department will take place from 15 January to 6 March 2020. Schools intend to participate in the competition must download the entry forms form of the Schools Dance Festival on our website. Please remind the teacher-in-charge of the dance team.**

Schools who do not intend to participate in the 56th Schools Dance Festival can also renew the School Membership this year to join our dance activities for teachers and students.

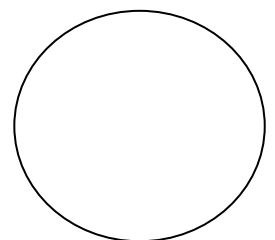
